In accordance with article 30 paragraph 2 of the Company's Articles of Association and Dutch law, persons entitled to attend and, to the extent applicable, to vote at the AGM will be those who were recorded as having those rights on 25 April, 2019 (the "**Record Date**"), in a register designated by the Managing Board for that purpose, regardless of whether they are shareholders or other persons entitled to attend the AGM. This means that shareholders and other persons intending to attend the

AGM need to hold their shares in the capital of the Company on the Record Date, but they do not need to continue to hold their shares until the AGM.

Copies of the Company's annual accounts, which include the reports of the Managing Board and the Supervisory Board, the explanatory notes and the personal data of Ms. Verluyten, Ms. Davidson and Ms. Bugno (in connection with their proposed appointment as members of the Supervisory Board), as referred to in Section 2:142 subsection 3 of the Dutch Civil Code in respect of the candidates for the Supervisory Board, as well as the other information included pursuant to law, will be deposited for inspection by shareholders and other persons entitled to attend the AGM at the Company's offices at Schiphol (Schiphol Boulevard 265, 1118 BH Schiphol Airport, the Netherlands) as of 27 March, 2019 up to and including the date of the AGM.
