The Program was approved by a shareholder resolution dated May 31, 2018 and by the supervisory board.

STMicroelectronics N.V. (registered with the trade register under number 33194537) (LEI: 213800Z8NOHIKRI42W10) (Ticker: "STM") announces the repurchase (by a broker acting for the Company) on the regulated market of Euronext Paris, in the period between November 19, 2018 to November 23, 2018 (the "Period"), of 1,106,227 ordinary shares (equal to 0.1% of its issued share capital) at the weighted average purchase price per share of EUR 12.2838 and for an overall price of EUR 13,588,683.87.
